

## 2014-3-5 Annual Town/School Dist Meeting

### Results of the Annual Town Meeting and the Town School District Meeting

Windham, Vermont ~ March 5, 2013

The legal voters of the Town of Windham and the Town School District met at the Town Meeting House in Windham, Vermont on Tuesday, March 5, 2013 from 10:00 A.M. until 3:29 P.M. and acted as recorded below.

#### ARTICLE 1:

Michael McLaine was elected as Moderator for Town Meeting and as Moderator for Town School District Meeting.

#### ARTICLE 2:

The Auditors Report was approved as presented in the Town Report.

#### ARTICLE 3:

All officers required by law to be elected at the Annual Town Meeting and Town School District Meeting were chosen.

Town Clerk - Alison Trowbridge was elected to a three-year term.

Town Treasurer- Peter Chamberlain was elected to a three-year term

Selectman - Mary Boyer was elected to a three-year term.

Lister - Michael Simonds was elected to a three-year term.

Auditor - Sally Hoover was elected to a three-year term.

Delinquent Tax Collector - Ernest Friedli was elected to a one-year term.

Grand Juror - Jim Scott was elected to a one-year term.

Town Agent - Michael Simonds was elected to a one-year term.

Windham Center Cemetery Commission - Margaret Dwyer was elected to a five-year term.

West Windham Cemetery Commission - Diane Newton was elected to a five-year term.

North Windham Cemetery Commission - Paul Wyman was elected to a five-year term.

Library Trustee - Cindy Kehoe was elected to a five-year term.

Windham School Director - Antje Ruppert was elected to a three-year term.

#### ARTICLE 4:

The School District will pay its Officers and Directors \$2,250 as included in the School Budget for 2013-2014 School Year.

#### ARTICLE 5:

The Windham School District authorized the School Directors to expend \$365,608.08 to defray the expenses of the Windham School District for FY 2013-2014 School Year.

#### ARTICLE 6:

The Town of Windham authorized the Selectmen to borrow money in anticipation of taxes for the current operating expenses.

#### ARTICLE 7:

The Town of Windham appropriated \$419,344.00 for Town Highways and Bridges.

Summer Roads: \$138,022.00

Winter Roads: \$226,322.00

Bituminous Retreatment: \$40,000.00

Bridge Maintenance: \$5,000.00

Construction: \$0-

#### ARTICLE 8:

The Town of Windham authorized the Select Board to purchase and incur indebtedness for new town highway equipment.

#### ARTICLE 9:

The Town of Windham authorized \$20,000.00 for the Board of Selectmen to retain the service of a professional appraisal firm in order to conduct a town-wide reappraisal and change from cost to market value appraisal.

#### ARTICLE 10:

The Town of Windham appropriated \$204,208.00 for the General Fund.

[Note: The appropriation totaled \$224,208.00 when the \$20,000 was added that was voted in Article 9 for the reappraisal.]

#### ARTICLE 11:

There was no other business which could legally come before this meeting.

The meeting was adjourned at 3:29 PM.
