Meeting Called to order at 6:30 pm by Frank

Agenda additions/deletions

- Social Services Committee discussion was rescheduled due to number of attendees
- Request from Select Board Committee to Secretary to include and maintain an Action Item list
- Bob Bingham received a Planning Commission resignation from Ken Grimes
 - There are two interested individuals
 - Chris Cummings & Vance Bell
- Frank presents the resignation letter of Town Clerk Jo-Jo Chlebogiannis
 - Claudia Voight will step in as interim Clerk until vote
 - Executive Session called to discuss/vote- Claudia Voight voted in as interim Clerk
 - Position must be posted for other candidates to apply

Adopt minutes

March 20th Meeting Minutes accepted with minor corrections

Road Crew monthly report

- Over weight permits (Town Clerk request)
 - They come through with insurance make certain filed properly, if declined has to come from road commissioner
 - Need to be part of the minutes
 - Need procedure so as not to lose, Allison has procedure
 - Can't go into mail until copies are made
- Write draft policy for abandoned vehicles and driveway culverts
 - Frank suggested road crew write a draft
 - Suggest to give warning/tag car to first offenders instead of towing
 - Difficult to see when poor visibility and concerns about hazards to public
- Schedule meeting with VTRANS to review roads budget
 - There is a certain amount of time after Town Meeting we need to meet with VTRANS
 - VTRANS available Wednesday Maureen is ok with that
 - Comment to road crew thanking them for the job they did this winter
 - George Dutton would like a slower speed limit sign on road to falls 30 mph suggested can put equipment ahead sign – will add to road sign order
- Schedule time for annual road crew evaluations
 - Road Crew to consider a time
 - Suggested to do them in May after mud season, date will be set as it gets closer

Cleanup from winter:

- Work to be completed:
 - Down trees, need to be chipped, clear pot holes, ditches for summer, cold patching –
 - Sweeping intersections, clean bridges, signs to put up, order new road signs for summer project
- Need to check how much money is available in paving account
 - Won't get rotating grant money for a few years
- Discussion about OSHA inspections and making certain all equipment is up to specs
 - John is taking osha related training
 - This will lead to greater training, must complete osha training first
- Culverts
 - Replacement should be scheduled for June
 - Concern was expressed about other projects falling behind due to lack of Town manpower if Town does the work and the need for Flaggers
 - A suggestion for Town to hire an outside contractor to do culverts as they have own flaggers
 - Request to have engineer do specs to include all needed equipment and misc. so we don't miss anything
 - Suggestion by Kord to draft policy for towns people re: culverts to clarify what is town/homeowner responsibility
- Equipment replacement schedule
 - Discussion around what was spent
 - 1/2015 to 3/2017 spent \$18,000+ on parts alone, battery/break issues..etc
 - Expense of keeping truck on road vs cost or replacing it mentioned
 - Had no interest loan for two trucks that have been paid off
 - General idea, \$60,000 voted in for replacement equipment –
 - One more payment on backhoe \$17,000 to be paid in June

Report on existing policies by Maureen

- There are only a few procedures/policies/ordinances
 - Frank responded that update possibly only if there is a change in town policy
 - Kord suggested reviews on occasion by individuals responsible for area such as roads.
 - Some would need to be reviewed annually and readopted
- Conflict of interest policy
 - Compared to Grafton's is too restrictive
 - Many of the rules don't apply to the town
- Kord had discussion re: Roberts Rules of Orders
 - Adopting a rules procedure for our town would be appropriate as RRO is restrictive
 - Rep Sarah Jarvis said she would come down to do presentation with heads of committees present

Green Lantern Solar panel proposal

- Energy committee received proposal from the organization to use field to install solar panels
 - Field was given to town. Select Board cannot determine, need town vote
 - Green Lantern wants to use 1 ½ acres would leave 270 x 80 foot strip between cemetery and area of use
 - Cemetery commission commented that the strip would give them enough room for next 100 years
 - Need to schedule town meeting to vote on this
- Green Lantern from Brattleboro is anxious to speak with board
 - Suggestion that Select Board take this as first step so can answer questions at town meeting
 - Maureen has read and reached out to Green Lantern with questions
 - Energy committee recommends that Select Board meet with Green Lantern rep and would like the support of the Select Board
 - Meeting with the Select Board will be setup
 - Suggestion made to have Green Mountain Rep.to also do a presentation at a Town Meeting
- Cemetery Commission was interested in having an expansion area
 - Commission drafted a proposal/100 year plan which includes landscaping
- Financial aspects discussed and where power will be distributed

- Jo spoke with Green Lantern there is a finder's fee that goes to town
- There would be no cost to the town and would be a financial benefit however town would have to spend some money at the on set
- Power would go into area grid
- Town would be an "off taker" and opportunity for towns people to buy off of it to reduce electric bills

Road Commissioner discussion

- Continued discussion about reorganization
- Kord was selected as Commissioner
- Frank wants to be sure road crew is involved with all aspects of decision making/giving input,
 make sure road crew get all the training needed
 - Josh recommended doing a quarterly meeting with Select Board
 - Road crew would attend meeting to discuss topics/concerns
 - Meeting would be open to public

Rescue Inc.

- Brought up at town meeting
- Town has donated money
 - Comment made re: should not donated, thought it was for profit, it is not a for profit
 - It's a 501-3C run by collaborative board from towns
 - Town pays aprox \$25 \$30 per resident you don't have to do whole population
 - Individuals can buy plan for \$65 year which eliminates deductible
 - Rep would come to do presentation to Board and answer questions
- Maureen mentioned a social services committee
 - There are already a number of interested individuals

Other Business

- Assistant treasure presented quarterly reports on budgets
 - Quarterly roads report copies presented
 - \$741,000 in general fund \$400,000 not spoken for
