## **Town School District Meeting**

**Article 5:** Shall the voters pay a salary of \$2250 (\$750 each) to the School Directors for FY 2017-2018?

**Article 6:** Shall the voters authorize the School Directors to expend \$378,842 to defray the expenses of the Windham Elementary School for the FY 2017-2018 school year?

## **Town Meeting Resumed**

**Article 7:** Shall the voters authorize the Town Treasurer to collect current taxes?

**Article 8:** Shall the voters appropriate \$192,461 for the General Fund?  
Voted 2016: \$186,105

**Article 9:** Shall the voters appropriate \$410,602 for winter and summer roads?  
Voted 2016: \$402,970

**Article 10:** Shall the voters appropriate \$90,000 for repaving and \$15,000 for the bridges and large structures fund?  
Voted 2016: \$95,000 for repaving and \$15,000 for bridges and large structures.

**Article 11:** Shall the voters appropriate \$60,000 in a new Road Machinery Replacement Fund?

**Article 12:** Shall the voters appropriate \$30,000 to the Windham Volunteer Fire Company?

**Article 13:** Shall the voters appropriate \$5,000 to the Windham Weatherization Fund to be used to reduce energy use and increase energy efficiency for Windham's public buildings?

**Article 14:** Shall the voters appropriate \$500 to Rescue Inc.?

**Article 15:** Shall the voters appropriate \$250 to the Windham County Humane Society?


**Article 16:** Shall the voters appropriate \$250 to the Townshend Food Shelf?

**Article 18:** To transact any other business that may legally come before this meeting.






