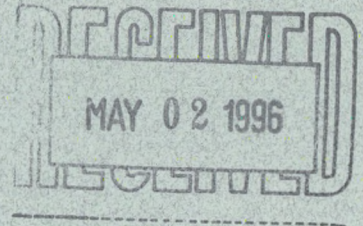

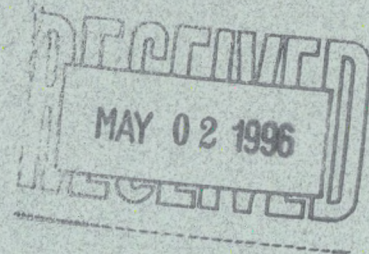

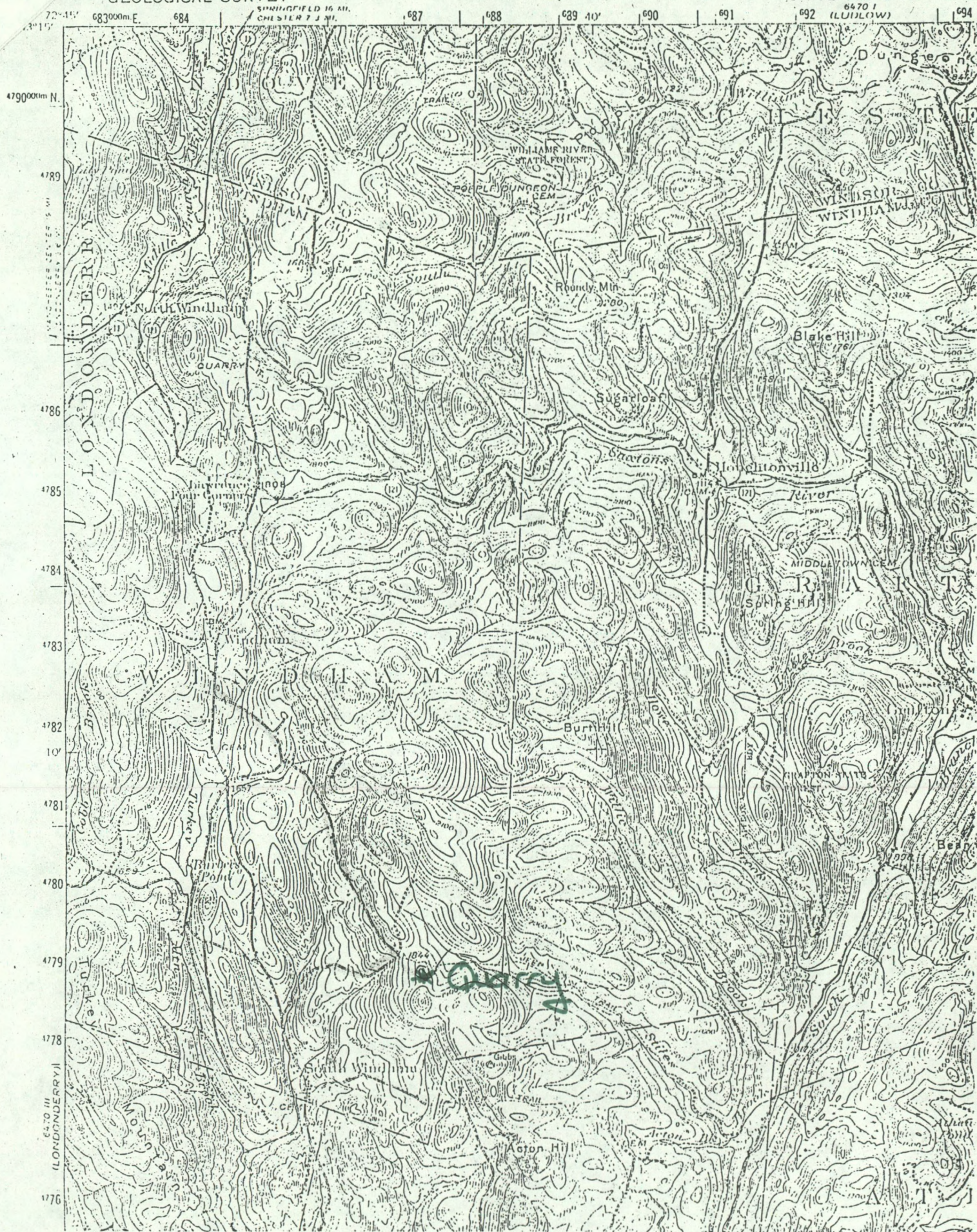

Thank you for the opportunity to comment on the above-referenced project.

The Division has reviewed this undertaking for purposes of Criterion 8, 10 V.S.A. Chapter 151 (Act 250). Project review consists of evaluating the project's potential impacts to historic buildings, structures, historic districts, historic landscapes and settings, and known or potential archeological resources. The purpose of the Division's review is to provide the District Environmental Commission with the necessary information for them to make a positive finding under the "historic sites" aspect of Criterion 8.

The proposed project for reactivation of the Windham Marble Quarry will not have an undue adverse effect on any historic or archeological properties that are listed on or that may be eligible for inclusion in the State or National Registers of Historic Places.
