The Division for Historic Preservation and the Vermont Advisory Council on Historic Preservation have reviewed the applications for the 1989 State Historic Preservation Grant Program and regret to inform you that your project was not selected for funding. Seventy-six applications were submitted to the Division requesting \$328,207 in matching funds, for projects totaling \$1,063,306. Legislative allocation of \$87,500 made the selection process a very difficult and competitive one.

We will keep your name in our mailing list, and if the program is funded in the future, we will send you the necessary application materials. In the meantime, if we can be of any technical assistance, we will attempt to be available to you as our staff time permits. We do appreciate your application and commend you on your commitment to Vermont's heritage. Good luck in your preservation efforts.

The Windham Church building was constructed in 1805 and is listed in the historical register. The front porch (deck) was in need of replacement. Upon removal of this structure it was determined that the 12 x 12 inch sill beam had deteriorated and the vertical supporting columns resting on this beam which in turn supported the bellfrey, was in danger of sagging in due time.

Three local carpenters undertook to relace this 180 year old beam and insert a 12 x 12 laminated pressure treated replacement. The chief difficulty was the need to hold up the massive structure while the old sill was cut out and move the new beam in place. Supporting outer braces were bolted in place on the exterior and interior. The braces were jacked up slowly until all pressure had been relieved from the sill beam and then the replacement procedure began. It was discovered that the two main vertical columns had sunk several inches into the rotted sill beam and that the sill beam itself had compressed and distorted by several inches.

The expense of this project was borne by the members of the church and by a donation from a group of friends dedicated to the preservation of this beautiful building.

The building is used for worship each Sunday and is the scene of numerous potluck suppers, a concert by the Chester Brass, Old Home Day, and is used for six weeks during each summer to host a summer camp for the children of the community. It is also the meeting place of the town providing the facility of a town hall; and the elementary school uses it for special occassions.
