

HE LEGAL VOTERS OF THE TOWN OF WINDHAM ARE HEREBY NOTIFIED AND WARNED TO MEET AT THE MEETING HOUSE IN WNDHAM, VERMONT ON TUESDAY MARCH 5, 2019 AT 10:00 O'CLOCK A.M. TO ACT ON THE FOLLOWING ARTICLES:

ARTICLE 1: To elect a Moderator for a term of one (1) year.

ARTICLE 2: To act on the report of the Auditors.

ARTICLE 3: To elect all other officers required by law to be elected at the Windham School

ARTICLE 4: To Compensate the School Directors \$750.00 each as included in the proposed School Budget for 2019-2020

ARTICLE 5: "Shall the voters of the Windham School District approve the school board to expend \$450,039 which is the amount the school board has determined to be necessary for the ensuing fiscal year?" It is estimated that this proposed budget, if approved will result in education spending of \$24,648 per equalized pupil. This projected spending per equalized pupil is 39% higher than spending for the current year.

AUDITORS' REPORT

We have examined the financial records and have compiled the accompanying financial statements of the funds of the Town of Windham, Vermont for the year 2018. We verified the existence of stated cash, balances and securities and examined supporting documents and securities relative to expenditures on a randomly selected basis.

We have reviewed all of the town's bank accounts and found them to be in order. For various financial reports we have relied on information provided from the records for the town.

Our examination should not be construed to be an Audit, Review, or Compilation as defined by the American Institute of C.P.A.s, but merely a review of account balances and activities that were conducted during the year. Our examination revealed no irregularities and we believe the accompanying financial statements reflect fairly the financial condition and the results of activities of the Town of Windham on December 31, 2018. We do not examine financial records of any other organizations or agencies included in this report.

PLEASE NOTE that the social services reports are no longer included in the annual report. There are copies in the Town Office and the Meeting House. You can copy any of these reports at the Town Office.

We wish to express our thanks to all who contributed reports. Special thanks go to Michael McLaine, our Town Clerk; Peter Chamberlain, our Town Treasurer; Ellen McDuffie, our assistant Town Clerk; and Kathy Scott, our assistant Town Treasurer. We appreciate their cooperation and all the extra work that they did to help make our job easier.

SELECTBOARD REPORT 2018

In direct contrast to when this report was written a year ago, today is a bright bluebird day, with temperatures ranging from below zero to the low teens! It's always something.

We're happy to report that volunteerism is alive and well here in Windham, whether it's serving on a committee, pitching in to help a neighbor, helping out at the Chicken BBQ, WCO, Town Office or Fire Company, to name just a few. We are grateful to all who worked and volunteered for the town this past year. We know how precious your time is and understand that allocating time to Windham with little or no compensation can be a sacrifice. We hear inspiring stories all year long and are reminded what living in a small town is all about.

You will likely see some new faces around town – we have an entirely new road crew in place, starting with Richard Paré who we proudly appointed as our Road Commissioner. You'll see him working with our new crew members, Dan Diaz and Kurt Bostrom. They work all hours of the day and night to keep our roads not only passable, but in great shape. Late in the fall they repaired seven failing culverts and are working to identify more that need to be repaired. Please give them a friendly wave when you see them around town.

Kathy Jungermann is a new Town Auditor in addition to co-directing the Emergency Management Committee with Imme Maurath. Russ Cumming is our newest Lister. Erin Kehoe is our new Delinquent Tax Collector. David Cherry and David Osborne were appointed to the Citizens Advisory Committee. Hal Wilkins was appointed to the Conservation Commission. Chair Alison Trowbridge has reactivated the Commission and among other things, they are bringing speakers to town and working to stay abreast of legislation that may affect us.

The Planning Commission updated the Zoning Regulations with an eye on updating the Town Plan in 2019, as is required by law. The Energy Committee has been actively seeking a location for a solar array. They also held another well-attended and informative Energy Fair in the fall, featuring contractors who would help "Button Up" your home. Currently, they are hard at work to bring the Town's Energy Plan up to speed.

There will probably be changes in store for The Meeting House. Be sure to read Windham News & Notes for all the latest information.

Town Office is operated by a generator in emergencies. During two lengthy power outages, the Emergency Management team opened it to serve as a warming center. People used the facility to warm up, eat something warm (from the microwave), charge devices and socialize. We plan to offer this service whenever we are faced with a prolonged power outage.

These, of course, are just some of the things that happened in town in 2018. There were many more events, classes, lectures, workshops and meetings attended and much work done by many of you. It really does take a village to get it all done.

We hope to see you at The Meeting House for Town Meeting at 10:00 on March 5. Please take time to read over this report and remember to bring it with you to the meeting.

Principal's Town Report—February 2019

Dear Windham Community Members,

General Update

This past year has invoked a great deal of conversation, thought, and emotion on the parts of so many people who care about and are invested in education in the state of Vermont. In particular, in our small town of Windham, this topic has been a hot one. Act 46 has caused many people to look at education and rethink how it best serves the children of Vermont in our rapidly changing world and amidst a diminishing state population of students. Specific to Windham, Act 46 has been another opportunity for many to show support for the school and to invest time in deciding what is best for the children in this town. Currently, there are still many variables at play and we are unsure of how things will play out specific to Windham elementary. At this point, the prevailing thought is that we remain as a k-6 public school for at least one more year.

Currently, we have seventeen students attending the Windham School. There are three children in kindergarten, three children in first grade, and one in second grade all in the same classroom taught by highly qualified teacher, Sally Newton. There are also seven students in fifth grade and three students in sixth grade being taught by highly qualified teacher Mickey Parker-Jennings. Mr. Parker-Jennings also serves as the school principal. Both his teaching and principal licenses are up for renewal this year in June. While Sally Newton renewed hers last year. In the upper grades' classroom, Mrs. Kehoe, who is also highly qualified and an extremely valuable member of our staff, works as the special educator with students who need assistance in any aspect of their academic instruction or understanding. Additionally, Mrs. Kehoe administers many of the assessments we use to drive instruction such as the Dibbles for reading, the Fountas and Pinnell assessments for language arts, and the Primary Numbers and Operations Assessment, PNOA, for math. Two other assessments we are using this year on an SU-wide basis are the Aims Web assessment, which is for math and language arts, and the Test of Written Spelling, TWS-5, which is obviously a spelling assessment. The Aims Web is particularly valuable as it can be used to check in on progress every couple weeks with the Progress Monitoring function. These results are important to help the teachers design the programming as the year progresses and to show progress for each individual student. These results are then shared with Leland and Gray so the staff there can have a more complete academic picture of the students they are receiving.

All the other members of this school community are just as valuable in keeping this school up and running at the level that is has for many years as the teaching staff. Gail Wyman is both the administrative assistant and teacher's aide in both classrooms. She does all the tedious secretarial work associated with running a school, while keeping Mr. PJ on task about anything and everything associated with being the teaching principal. She also works with students at various points throughout the day helping students to gain greater understanding with things they are confused about, or offering an extension of the topics covered in the classroom. She truly is an exceptional member of our school team who has to have amazing patience, flexibility, and a great sense of humor to deal with Mr. PJ all day! Gail's husband Paul is the building custodian. Paul comes in every other day to clean the school, fix minor problems, and do whatever we ask of him from a custodial perspective. He is a wonderful calming influence on the school.

We also have our "bus driver" Kord Scott. I put the words bus driver in quotes because Kord does far more than drive the bus. Not only has Kord been invaluable as a bus driver, but even more so as our heating and cooling specialist. His knowledge of the boiler system continues to save us on many occasions. We also have a licensed school social worker, Susan Gunther-Mohr, who comes once a week to work on whole class instruction around social emotional health, small group issues with students who need to talk in a guided environment, and individual meetings with students, when permission is granted from the families, to talk about anything on their minds. Susan is also available for families to use as a reference when dealing with difficult times or having questions about adolescence. The time spent with Susan is heavily valued by the students on a weekly basis to talk about issues in their personal lives. We also have Kate Ullman for music class and chorus class on Friday afternoons, as well as two concerts a year. Kate has also taken several of our students to state and national choir events around the country over the years. PE continues to be twice a week and is taught by Carla West on Wednesday afternoons and Thursday mornings. She also teaches them health during those time slots and joins us for our winter sports program on Wednesday afternoons during the winter months. Art is done by volunteers both here at school and down at the field house with Meadows Bee Farm. Several weeks of our art class is spent at the ceramics studio at the field house learning about basic clay and glazing techniques.

Adequate Yearly Progress (AYP) 2017-2018

Academic progress has always been a source of pride for the staff and students here at Windham School. Over the years we have heard back from teachers at Leland and Gray about how well our students are doing or about how well prepared they are from both an academic perspective as well as a social perspective. Reporting adequate yearly progress is challenging for us to do, as we are not allowed to report out on any one grade that is less than ten students. Given we do not have enough students in any grade level to meet that cut-off, we cannot report out our results on any state-wide assessments. Our sample size "n" has not been met for state approval to share out our results. Individual families do have access to the results of their specific children. The entire supervisory union continues to use the Aims Web assessment to help track academic progress. This is a test for both math and language arts based on the Common Core State Standards(CCSS) that is taken three times per year in the fall, winter, and spring. This spring will be the second administration of a science based Smarter Balanced Assessment Consortium(SBAC) test, which is replacing the New England Common Assessment Program(NECAP) science assessment based on the Next Generation Science Standards(NGSS).

Special Programs and Projects

We continue to strengthen our partnership with Meadow's Bee Farm for a variety of learning opportunities and experiences. The students continue to spend time there learning about aspects of a working farm, while earning badges for their progress in specific areas such as bee keeping, dairy work, woodlands, and blacksmithing. This program remains a point of envy for other schools and staff in the SU. We also continued our partnership with the Weston Playhouse and the Early Stages program. Last year was the play Anne of Green Gables as the focus. This program involves students creating, writing, developing, and performing an original production on stage at the Weston Playhouse! Also this past year, we worked with the Brattleboro Art Museum to expand students appreciation for art. We have had guest presentations here at the school about specific artists and spent time at the museum working with Linda Whelihan.

Facilities and Equipment

The new addition of a buzzer and camera to enter the school has been a huge improvement to the safety of our students and staff. There are no longer people entering the building without our knowledge or without at least being seen first. The other cameras continue to work well all around the school building exterior to offer enhanced security and help prevent after hours vandalism or kids hanging out in the field at night. The exterior of the building was painted by volunteers last year and looks much improved.

Windham Elementary School Director's Report March 5th, 2019

For quite a few years now, the Directors of Windham Elementary School have been working with the Windham Central Supervisory Union in an effort to satisfy the state's mandate to consolidate governance structure, meaning, a consolidation of individual school boards. This did not, at the time, mean consolidation of schools.

The Agency of Education believes there are too many school boards for the supervisory union to deal with and they pushed for a consolidation of governance and what we now feel includes a consolidation of small schools. This subsequent measure has come under the guise of Act 153, The Red, Act 46, and the MUDD, now known as the WRMUED – West River Modified Union Education District, newly formed this past fall, which includes Townshend, Brookline, Newfane and Jamaica. While we respect this union, we did not feel it secured a school for our future students. The Windham School Directors have been wary of this measure after many meetings and conversations. Vermont's small, rural schools have become a target due to increasing education costs and low enrollment which is not uncommon across the country.

Windham has a long history of passing a budget in support of not only our children but also children from other schools throughout the state of Vermont. Regardless whether we have a school or not, we will continue to be required to raise one extra dollar for every dollar raised for our school budget. The reality of bussing children out of town also raised questions as to parent participation, amount of time students would spend on the bus, co-curricular participation, and transportation thereafter. There are too many unknowns at this point. The state is lacking in its education funding system as is apparent by the additional costs WES will incur for special education in our next budget. This issue will be discussed at our informational meeting with the help of our Superintendent William Anton and WCSU CFO, Laurie Garland. Bill and Laurie have been very supportive and helpful as we navigate Act 46. After much time spent attending meetings along with Carolyn's work in Montpelier, the Windham School Directors along with several townspeople found that there were no benefits, neither educationally nor financially, in giving up our elementary school at this time. In fact, we felt that it could potentially be a detriment to not have a school in our town in terms of attracting new families to Windham, our property values, etc.

Instead, along with many towns in Vermont, we decided to challenge Act 46 based on its unconstitutionality regarding the taking of property. We have joined a significant number of school districts and individuals in a law suit against the State Board and its decision to force mergers. Many of you will remember the meeting on November 26th, 2018, where we presented a case for selling the school property to the town in such an event. If we are forced to merge with the WRMUED without securing our school building, the WRMUED Board will take ownership of the school and all of its assets and the town will lose all of its rights to it. This and a few other factors made the case for the Windham School Directors. WES is rural and deemed geographically isolated because of our high risk Windham Hill Rd., and the distance to the nearest school. The fact that we only have one vote on the WRMUED board was also a concern as it leaves us with little representation.

At this time, we want to be proactive and consider all options. A group has formed to explore the option of becoming an independent school. It is our belief and supported by many community members, that we continue to move forward and grow the opportunities available to our youth right here on our mountain. Aside from our fantastic ukulele club, the Weston Theater program, the Space program, and JISP, students participate in farm school and the Young Farmers Badge Program at Meadows Bee with the added learning environments created with the Field House ceramics studio, blacksmithing shop, herbal laboratory, and agricultural library. We feel we have so many amazing programs to offer our children right here in our community that are not available anywhere else in the WCSU school district. Due to the litigation, we are in a stalemate for now and will move forward in the meantime to brainstorm what WES can actualize, and perhaps create something really special, unique to Windham. This is the time to dream big and keep our options open to the possibilities for our community.

Windham Central Supervisory Union Superintendent's Letter 2019

The Windham Central Supervisory Union continues to grow and change. As of July 1, 2019, the PreK-12 <u>West River Modified Unified Union Education District</u> (Brookline, Jamaica, Newfane, and Townshend. Windham's level of inclusion has yet to be solidified) and the Pre-K-12 <u>River Valleys Unified School District</u> (Dover and Wardsboro) will become fully operational.

Marlboro School District will continue to operate as a PreK-8 school with 9-12 school choice. Stratton School District continues as a non-operational PreK-12 tuition school district.

The WCSU is in the midst of its third year of forward momentum. We have established a high functioning leadership team consisting of building principals and central office cabinet members. Our deeply committed education professionals have continued to engage in professional development in the areas of Math, English Language Arts, and Personalized Learning. This past year we have added Supervisory Union wide professional development in creating Trauma Informed schools. In particular, our building principals and our teachers have continued to deepen instructional skills in addressing a wide variety of student needs.

For the 2019-2020 school year:

The West River School District is implementing elementary school choice, creating a 6th-8th middle school, and offering full day PreK 4, with a PreK 3 pilot continuing.

The River Valleys School District is implementing elementary school choice, expanding PreK 3, and developing a cultural focus for the Wardsboro School to compliment the Dover School's recent authorization as an International Baccalaureate school.

The Marlboro School District is reflecting on their mission and integrating several new educational professionals into their school.

The Windham School District continues to evaluate all of their options as they serve the students, parents, and the community of Windham.

I encourage everyone to get informed during the budget season. Your school boards have worked diligently to craft responsible budgets reflective of student needs and value to taxpayers.

TOWN OF WINDHAM

HEALTH OFFICER REPORT

2018

During the past year I continued to write articles for the Windham News & Notes regarding health issues. The articles discussed repellents effective against ticks and care of tick bites; the new, more effective shingles vaccine (which is now on back order nation-wide); and the necessity of annual flu shots.

Throughout the spring and summer I made spot checks of a property to inspect for improper disposal of garbage, creating a public health hazard that would attract animals. The owners were cooperative and after a written notice have kept their property clean.

The Vermont Department of Health advises that coliform/E.coli bacteria testing be done annually of home drinking water. The necessary kit can be ordered either from the state lab or from a private lab in Hartland, VT. The private lab is easier as it includes a pre-paid mailing envelope. I have developed a handout that explains the procedure and gives the necessary information. The Vermont Department of Health offers many air and water test kits which can be found on www.healthvermont.gov. The latest news from the Department Health can also be found at facebook.com/healthvermont and twitter.com/healthvermont.

If the residents of Windham have any concerns regarding health issues of their home or environment, please contact me. I have handouts on a variety of subjects and can direct a question to the appropriate source if needed. Also I have plenty of emergency preparedness workbooks for anyone who would like one. This is an excellent source the state has published that will help you organize you and your home to be ready for any emergency.

Listers' Annual Report

for 2018

The job of the Windham Listers is to assess each property accurately, fairly and impartially in order to determine its fair market value. The total assessed value of all property is stated on the Grand List. The Grand List and the budget approved by Windham voters at Town Meeting are used to set the municipal tax rate. The total Grand Lists of all Vermont towns and the school budgets of all Vermont towns are the basis upon which the state legislature sets the statewide education rate. The Listers do not set the tax rate.

The state has formulas to determine the accuracy of each town's appraisals as stated in its Grand List, and there are financial penalties to a town if it is too low. If we are very high or low, the state can force us to do a total reappraisal with a visit to every property in town.

The two main numbers that affect Grand List value and which can force a town-wide reappraisal are the Common Level of Appraisal (CLA) and the Coefficient of Dispersion (COD). The CLA is the sum of the assessed values of Windham's properties sold over the past three years divided by the sum of the sale prices of those same properties. The COD looks at each individual property sold over the last three years, measures the difference between its sales price and the assessed value, then calculates the town's overall appraisal accuracy.

The chart below shows the years the CLA and COD rates were applied. The rates are based upon the sales of the previous three years. Thus, the rates for 2017 are based on sales in 2014, 2015, and 2016. The lower the COD, the closer the assessed values to the sales prices and the more accurate and equitable the appraisal.

(This usually involves completion of a new house, additions to an existing house, or completion of a barn or garage.) Letters will not go out to those whose values have not changed.

LONDONDERRY SOLID WASTE GROUP

Serving the towns of Landgrove, Londonderry, Peru, Weston, Windham

This past year has seen some changes for the Londonderry Solid Waste Group (LSWG). Cash has **not** been accepted at the Transfer Station since October of 2017. The new Punch Card Payment System is working well with punch cards available at all five town offices as well as Londonderry Hardware and Weston Marketplace.

Annual Transfer Station Stickers that allow access to the Transfer Station, whether you are recycling or disposing of trash, are now available at all five town offices.

LSWG conducted two Household Hazardous Waste (HHW) Collection Events and one Electronics Collection Event in 2018. The 2019 HHW collections will be the first Saturday in June and the first Saturday in October. The group has an agreement with Rutland's year-round hazardous waste facility and members can bring their hazardous waste to that facility year-round. There is a fee for disposal. Please do not bring your electronics to the transfer station. You can dispose of them at any of the sites listed at www.vtecvcles.org or call 1-855-63-CYCLE

LSWG's Recycling Coordinator and TAM Solid Waste Inc. teamed up to conduct a trash sort at the Londonderry Transfer Station in September. The previous sort was done in 2013. While it isn't an exact science, the sort results were indicative of how much we have improved since then. There was more trash in the trash and less recyclables. The biggest loser was mixed paper that could have easily been recycled.

Textiles are once again accepted at the Transfer Station. Please bring them in bags and deposit them in the yellow bins.

Extended Producer Responsibility (EPR) programs offer FREE disposal of architectural paint, batteries, electronics, mercury thermostats and mercury containing bulbs. To find out more about these programs and where you can dispose of these materials go to www.vtrecycles.com or call 1-855-63-CYCLE.

The LSWG reached out to schools and businesses in 2018 providing guidance on recycling, disposal of hazardous materials and diverting food scraps and organics from the landfill. If your school or business is interested in learning about ways to handle solid waste, organics, recyclables and other materials please contact recycle@londonderryvt.org.



The Windham Regional Commission

The mission of the Windham Regional Commission (WRC) is to assist towns in Southeastern Vermont to provide effective local government and to work cooperatively with them to address regional issues. In the absence of county government, we provide an essential link between towns, the state, and the federal government. The region is comprised of 27 member towns: the 23 towns of Windham County; Readsboro, Searsburg and Winhall in Bennington County; and Weston in Windsor County.

The Commission, a political subdivision of the state, is composed of and governed by town-appointed Commissioners. Towns choose their own representatives to serve on the Commission. After town meeting, each Selectboard appoints up to two representatives to serve on the Commission for the coming year. Windham is currently represented by Carolyn Partridge and Bill Dunkel. Each Commissioner represents their town's interests before the Commission, brings information from the Commission back to their town, and serves on at least one of a number of WRC committees that address regional and municipal issues and concerns. Active service on these committees is very important because the WRC is organized around a strong committee structure. It's within these committees that most Commission decisions are made. All WRC meetings are open to the public and subject to Vermont open meeting law.

We assist towns with a number of different activities, including town plans and bylaws; community and economic development; local emergency and hazard mitigation planning, including flood hazard and river corridor bylaw assistance; natural resources, including assisting towns with watershed restoration projects and implementation of the state's new clean water law; Act 174 town energy planning; transportation, including traffic counts (automotive, bicycles, pedestrian), inventories (bridges, culverts, signs, road erosion), road foremen training, and serving as a liaison with VTrans to report damage to town road infrastructure to the state as a result of flooding; redevelopment of "Brownfields" sites (sites that are or may be contaminated by hazardous substances); review of projects submitted for review through Act 250 (land use), Section 248 (energy generation and transmission, telecommunications), and federal permitting processes; grant application and administration; training of municipal officials and volunteers across a range of topics; and mapping and geographic information system (GIS) analyses. The maps in your town office were likely produced by the WRC.

We help towns make the most of the financial and human resources they have both individually and collectively, assisting with projects between and among towns, building and augmenting the capacity of volunteer-based town boards and commissions, and providing professional services to towns that may want to take on a project that is beyond what they can comfortably manage with their own staff and volunteers. Our relationship with towns is inherently collaborative. For instance, towns may choose to have their plans reviewed by the Commission; town plan review and approval by the WRC is not mandatory. The regional plan, which was updated in 2014 following a two-year process, is developed in consultation with member towns, reflects town plan policies, and is ultimately approved by our towns.

Past year highlights reflect the range of services we provide to the towns of the region. We've begun a pilot study in collaboration with the Rich Earth Institute to explore innovative technologies that can help address village wastewater capacity and groundwater quality issues. We continue to support the development of watershed collaboratives, and participate in efforts like the Confluence Project, which bring together diverse stakeholders and citizens to better connect with their shared watersheds to improve water and habitat quality. We're leading two renewable energy grant programs. One provides assistance to schools and other public buildings to install modern wood-fueled heating systems. The other provides grants for renewable energy development. We've helped towns apply for grants to conduct road erosion inventories and conduct road erosion work. We assist towns with local emergency operations planning. We also continue to be the primary GIS and mapping resource for our towns. An annual report is available on our website (www.windhamregional.org). Click on the heading "About Us." We encourage you to visit your town's page on our website to see highlights of our work for you over the last two years, as well as your town's profile (http://windhamregional.org/towns). A video about the WRC is available on our homepage.

Funding for the WRC is provided through contracts with state agencies, federal grants, and town assessments. Town assessments make up a relatively small percentage of our budget; about 5% of a 52.25 million budget for FY 2019. But it is the only funding we receive that has no conditions placed upon it by entities beyond the WRC's borders. Your town's assessment makes it possible for us to leverage the resources to serve you. The town's assessment for this year is \$956. - Discussion went on to revolve around Salaries as example the Principal Salary however it was brought forth
 that the Principal is a teaching Principal, actually holds two positions Salary needs to be comparable to other
 positions in Vermont otherwise it is difficult to find qualified individuals to replace. Medical insurance is also not
 paid for the Principal position. It was also mentioned that next year's school attendance will be increasing.

Solar Array Discussion:

Bill Dunkel – Energy Committee – took this time just before the group adjourned for lunch to talk about the
proposed Solar Array which would be located on land given to the Town, East of the Central Cemetery. Part of
the land would be used for burial; even with the extended burial land it leaves open area which could fit
approximately 600 Solar Panels. The Panels would not be visible from the road given the way the land falls.
There would not be any cost to tax payers; Bill went on to talk about the various benefits to the Town and the
tax payers. He invited the tax payers to attend a public information session which was scheduled for the
following Monday at the Town Meeting Hall.

 - Town voted all in favor

Article 12: Shall the voters appropriate \$100 for Gerda's Equine Rescue?

- · Brief discussion ensued to clarify what the Article is and where do the horses come from.
 - Gerda Equine Rescue is a 501 (c) (3), Gerda is also setting up work study at Leland and Grey for students
 - o Town voted all in favor

Article 13: To transact any other business that may legally come before this meeting.

- Pat Cherry from Neighborhood Connections thanked the Town for this year's donation She discussed what
 the Organization does, the towns covered, how the Organization helps the community. She discussed the new
 initiative which is called Helping Hands, the focus of which is to help the elderly/disabled individuals with home
 repair to keep them safe. Appreciates any contributions anyone would like to donate.
- Leigh Merinoff discussed the West River Community Projects, their focus to help individuals. Is also a 501 (c) (3).
 They would appreciate any donations/contributions. In addition, the Farmers' Market welcomes volunteers.

Windham Report

The Windham County Sheriff's Office provided an augmented police service to the people of Windham FY2018 (July 1, 2017 to June 30, 2018) in the amount of \$5000, or approximately 98 hours of service for the year. Our office was able to provide 100.25 hours of service, at no additional cost to the town. The service provided included motor vehicle enforcement and response to 62 calls for service, or calls where response would not be provided by the town's primary law enforcement agency. During FY18, we issued a total of 60 tickets. Under Vermont law, the town could receive up to \$6040 in fund disbursement from the Vermont Court Administrator's Office/Vermont Judicial Bureau from this ticket revenue. Additionally, 8 warnings were issued and 62 calls for service were answered.

While overall, this year has been one of maintenance for the Sheriff's Office, a couple new things have come to be. This year we took over coordination of the Windham County Highway Safety Task Force, a regionalized law enforcement effort funded by the Vermont Governor's Highway Safety Program to provide education and enforcement efforts across Windham County.

We've updated our portable radios to improve deputies abilities to communicate while in the community; begun/continued work to increase our radio coverage with additional transmission locations; purchased three cruisers, including an unmarked Dodge Charger to facilitate out-of-state prisoner extraditions and movement of mental health patients, a Ford Interceptor Sedan to update our patrol fleet, and a Ford Interceptor SUVs to update our transport fleet; we replaced our deputies body armor utilizing grant funding; provided our deputies with up-to-date high-visibility jackets to keep them safe while on patrol; and replaced our cruisers' flashlights.

As in year's past, we provide several programs to the citizens of Windham County. These programs are provided by leveraging grant funds and other sources of funding, and are not charged to the contracted towns or villages. These programs include Click It or Ticket, Are You Okay?, DUI campaigns, the Drug Evaluation and Classification Program, Work Zone Safety Enforcement, Toys for Kids, and snow mobile patrols. We continue to maintain secured anonymous drug disposal bin in our lobby, to help the citizens of our community safely dispose of unwanted/unused prescription medications. It is the continued support of Windham and other towns which help contribute to our ability to provide these no-cost services to Windham County as a whole.
