**H.C.R. 100**

House concurrent resolution recognizing May 19–25, 2019 as National Public Works Week in Vermont

Offered by: Representatives LaClair of Barre Town, Brownell of Pownal, Gannon of Wilmington, Harrison of Chittenden, Hooper of Burlington, McCoy of Poultney, McFaun of Barre Town, and Savage of Swanton

Whereas, public works are central to many aspects of our lives, and

Whereas, the durability of the State's roads and bridges and the promptness of highway road clearance following a major storm are critical responsibilities of public works departments across Vermont, and

Whereas, depending upon the jurisdiction, a municipal public works department may also be responsible for essential water and sewer infrastructure systems, and

Whereas, the sophisticated equipment that is used to achieve these objectives requires the operational expertise of skilled public works employees, and

Whereas, each year, the American Public Works Association designates a week in May as National Public Works Week to celebrate the role of public works in each of our communities, and in 2019 the selected week is May 19–25, and

Whereas, "It Starts Here" is this year's National Public Works Week theme, which "represents the many facets of modern civilization that grow out of the efforts put forth by the public works professionals across North America," and

Whereas, in the same spirit as the national observance, the Vermont Municipal Highway Association will hold its 36th annual Field Day & Plow Contest on Wednesday, May 8 at the Barre Auditorium in anticipation of this important week, now therefore be it

Resolved by the Senate and House of Representatives:

That the General Assembly recognizes the week of May 19–25, 2019 as National Public Works Week in Vermont, and be it further

Resolved: That the Secretary of State be directed to send a copy of this resolution to Vermont Municipal Highway Association Secretary-Treasurer Harry Hinrichsen.

**WEST RIVER MODIFIED UNION EDUCATION DISTRICT**  
**SPECIAL MEETING**

**June 11<sup>th</sup>, 2019**

The legal voters of the West River Modified Union Education District, comprising the voters of the towns of Brookline, Jamaica, Newfane, and Townshend for prekindergarten through Grade 12 and the Town of Windham for Grades 7-12, are hereby notified and warned to meet in their respective towns at the polling places hereinafter named on June 11<sup>th</sup>, 2019 to vote by Australian ballot on Article 1 & 2 below. The polls will open beginning at 9:00 a.m. in Brookline, 10:00 a.m. in Jamaica, 9:00 a.m. in Newfane, 9:00 a.m. in Townshend and 10:00 a.m. in Windham. The polls will close in all such towns at 7:00 p.m.

**ARTICLE I:** Shall West River Modified Union Education District accept Windham Elementary School District as a full member of West River Modified Union Education District Union School District, effective July 1, 2019, per the State Board of Education's Final Report of Decisions and Order on Statewide School District Merger Decisions (Pursuant to Act 46, Sections 8(b) and 10) dated November 28, 2018, and under the terms of the Articles of Agreement certified by the Secretary of the Agency of Education on May 28, 2017.

**ARTICLE II:** Only in the event Article I is approved, shall the voters of West River Modified Union Education District #34 amend the voter approved 2019-2020 school budget of \$11,710,082 by adding \$450,039 which is the amount necessary for anticipated expenses at the Windham Elementary School for the 2019-2020 school year. It is estimated that this revised budget, if approved, will result in education spending of \$20,900.09 per equalized pupil.

**Note: Article II is contingent upon the passage of Article I.**

Said persons and voters are further notified and warned that a public informational meeting on the Article 1 & 2 will be held on June 6<sup>th</sup> 2019 at 7:00 P.M. at the Leland and Gray High School Library in Townshend, Vermont; the voting on said Article will be by Australian ballot on June 11<sup>th</sup>, 2019. 
