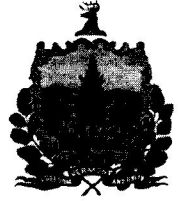

Dear Selectboard,

As some of you no doubt read in the papers, I was appointed by Governor Phil Scott on July 11th, 2019 as the Sheriff of Windham County. While new to this particular role, I am entering my sixteenth year serving Windham County and it is likely we have already met, or at least conversed in some capacity.

The Windham County Sheriff's Office (WCSO) is an organization of dedicated, motivated, highly trained professionals. We provide services both conspicuous and discreet throughout Windham County and Vermont, including but not limited to: community policing, prisoner transportation, civil process, regional dispatching, functioning as the county fingerprint station, and coordinating regional crash reduction efforts. Via this letter, I'm hoping to make clear my intention to both continue these services, while possibly expanding them to meet your own individual, community-specific needs.

Already, I have identified new and better ways to serve Windham County than in the past. We've begun to reduce municipal costs in emergency dispatching; enhanced our staff to handle criminal investigations and quality of life policing issues; and we're helping to place the county at Vermont's forefront in responding to opioid related deaths, specifically training our staff in responding to this crisis and developing interdisciplinary relationships with partners.

These are only some of the issues that we've identified, but I am sensitive to Windham County's diversity and the many unique needs of the towns within it. As such, I would like to make this an open-ended offer of dialogue with each and every town or village, whether the WCSO has an active contract with you or not. I would, in short, like to make this transition of leadership an opportunity to hear issues that affect you, and to tailor whatever services we can provide you in the future.
