CONTRACT FOR LAW ENFORCEMENT SERVICES AMENDMENT

THIS AGREEMENT made this 3rd day of August 2020 by and between the Windham County Sheriff's Office having its office in Newfane, Vermont and the Town of Windham having its office in Windham, Vermont that contract # 20-022 is changed as follows:

- 1. **Term.** On Page 5, Section 10, shall be changed to read: The term of this Agreement shall be July 1, 2020 to June 30, 2021.
- 2. Term. On Page 5, Section 11, shall be changed to read: On or before November 1, 2020, the Office shall notify the Town of Windham of the contract rates for the following year. Sixty (60) days prior to the end date of this Agreement, the Village shall provide the Office with written notice of whether it will renew the Agreement. Absent such notice, this Agreement shall automatically renew for a term of one year at the contract rates set by the Office in the notice.
- 3. Effective date. The effective date of this amendment is July 1, 2020.
- Except as modified by this amendment and any and all prior amendments to this contract, all provisions of the original contract # 20-022 dated <u>July 1, 2019</u> shall remain unchanged and in full force and effect.
- 5. Governing Law. This contract will be governed by the laws of the State of Vermont.
