## Statement in Support of Carolyn Partridge for BCA Meeting, November 30, 2021 Submitted by Michael Simonds

I want to speak here tonight in support of Carolyn Partridge. She has more than a 30-year record of personal service to the citizens of Windham. She has served on the Select Board and the School Board. She is a justice of the peace, a long-time member of the Windham Community Organization, and a member of the former Windham Congregational Church. Carolyn has served as our state representative for almost 20 years, and is the chair of the Argriculture Committee in Montpelier.

Carolyn has been a mentor and provided support to countless individuals over the years, including my wife Mac and myself. When I first bought property and moved to Windham, I was living in a tent and trying to figure out how to build a house with no knowledge of contractor service people or local and state regulations, and I had no phone. I had driven past the farm on Old Cheney Road a few times and decided to stop in and ask about contractors and if I could use their phone. Well, Carolyn and Alan knew people and suggested who to hire, and they had a phone extension in their garage, which they said was *my* phone which I could use anytime for local or long distance calls. I was one of the nicest and most helpful acts of support I have ever experienced.

Carolyn also recruited me for town committees. In my 25 years in Windham, I have served in eight different offices. When Mac later came into my life, Carolyn got her involved as well. You can find many people in town who have similar stories. Carolyn has always been there with advice and support, and if you needed it, a shoulder to cry on. Mac and I are constantly amazed that she can do all of these things while mending fences, farming sheep, spinning wool, and growing a lot of their own food. She also keeps chickens who produce the best eggs we've ever eaten. In addition, Carolyn has raised three sons who graduated from Windham Elementary School and have gone on to have successful careers.

Perhaps most importantly, Carolyn maintains the highest level of integrity. In my 25 years as her neighbor, I have never known her to do anything dishonest. To the contrary, she is someone who speaks the truth even when she knows it is not what others want to hurt, and even when she's aware that it might cost her votes. She is a person who acts on her principles, and first and foremost of these is to act honorably and honestly.

That is why we and all the other people in town who love and care about Carolyn are shocked and dismayed that she has been accused of a criminal offense and that her name and reputation are being dragged through the mud.
