

**1995 AMENDMENT TO TOWN ORDINANCE FOR THE CONSTRUCTION OF  
ROADS, TOWN OF WINDHAM**

Pursuant to the provisions of Title 19, Sections 304(A)(23), and the provisions of chapter 59 of Title 24, it is hereby ordained by the Board of Selectmen that the following amendment to the Windham Ordinance for the Construction of Roads be adopted for the Town of Windham, Vermont:

**D. ENFORCEMENT**

A violation of this ordinance shall be a civil matter enforced in accordance with the provisions of 24 V.S.A. section 1974a and 1977 et seq. A civil penalty of \$100.00 shall be imposed for the initial violation of this ordinance. The penalty for the second offense within a six month period shall be \$150.00, and the penalty for subsequent offenses within a six month period shall be \$200.00.

The waiver fee shall be set at \$50.00 for the first offense, \$75.00 for the second offense within a six month period, and \$100.00 for subsequent offenses within a six month period.

Each day that the violation continues shall constitute a separate violation of this ordinance.

The custodial official of the Town's ticket books shall be the Town Clerk.

The issuing officials shall be the members of the board of selectmen, the town constable, any sheriff, police officer or state police officer and the Town highway foreman.

The appearing officials shall be the members of the board of selectmen, the Town grand juror, the Town highway foreman, and the Town's attorneys.

E. DESIGNATION

This ordinance is designated a civil ordinance pursuant to 24 V.S.A. section 1971(b).

Under the provisions of Chapter 59 of Title 24, Vermont Statutes Annotated, the Board of Selectmen, Town of Windham, hereby adopts this Amendment to Town Ordinance for the Construction of Roads this 17<sup>th</sup> day of July, 1995.

Week of This Amendment shall be published in the "Message" on July 24, 1995 and filed with the Town Clerk of the Town of Windham on July 18, 1995 and shall become effective on Sept 16, 1995, unless a petition is filed in accordance with section 1973, Chapter 59, Title 24, Vermont Statutes Annotated.
