To member municipalities:

In the late 1990's, shortly after the passage of Act 60, the law which instituted a statewide education property tax, a group of like-minded municipalities banded together to form the Vermont Coalition of Municipalities, incorporated as the Vermont Foundation for Equal Educational Opportunity, Inc., to advocate for a more equitable education funding system.

Given the dormant state of the Vermont Coalition of Municipalities for many years, with no relevant purpose in today's political climate, on April 9, 2018, the Coalition's Board of Directors voted to dissolve the corporation, as provided in Section 4 E (e) of the corporation's bylaws and state statute 11B VSA §14.02 (a) and distribute the balance in the corporation's accounts, \$28,746.73, to member municipalities pro-rated on the basis of each municipality's contributions to the Coalition.
