This is a Quasi-Judicial Hearing. The public may listen but may not participate.

#### **AGENDA**

- 1) Start recording and call meeting to order
  - a. a. Announce that Ellen is the Clerk of the BCA
  - b. BCA members take the following Oath: "I do solemnly swear (or affirm) that I will well and truly and determine all matters at issue between taxpayers and listers submitted for my decision, so help me God. (or "under the pains and penalties of perjury.)"
  - c. Adopt the Rules of Procedure
- 2) Additions/deletions or changes to the agenda
  - a. Elect a Chair
  - b. Announce that this is a "Quasi-Judicial Proceeding" and read description: "Quasi-judicial proceeding" means a contested hearing as defined by the Vermont Municipal Administrative Procedures Act, 24 V.S.A. Sections 1203-1209, as amended, or a case in which the legal rights of one or more persons who are granted party status are adjudicated, which is conducted in such a way that all parties have opportunities to present evidence and to cross-examine witnesses presented by other parties, which results in a written decision, the result of which is appealable by a party to a higher authority.

- 6) Appellant presents their valuation and supporting evidence
- 7) Ask the Listers for their response
- 8) Invite questions from BCA members
- 9) Clerk collects all written evidence; listers may review it and may make objections
- 10) Chair appoints 3 person BCA inspection committee and recommends time and date. Chair describes inspection process.
- 11) Recess to a Time & Date to reopen the hearing (in not more than 30 days) to hear results of inspection committee.

The town clerk forthwith shall call a meeting of the board to hear and determine such appeals, which shall be held at such time, not later than 14 days after the last date allowed for notice of appeal, and at such place within the town as he or she shall designate. Notice of such time and place shell be given by posting a warning therefor in three or more public places in such town, and by mailing a copy of such warning, postage prepaid, to each member of the board, the agent of the town to prosecute and defend suits, the chair of the board of listers, and to all persons so appealing.
